PROFESSIONAL REPORTS

Mr. John Napolitano Esq:

Mr. Napolitano discussed Item #2 Meadowlands Rebuild: Response to AECOM Engineering for the proposed relocation of Main Line at Starke Road. At our last meeting, AECOM had requested we review plans. Mr. Napolitano drafted the agreement to recover costs incurred by the CSA. AECOM informed the Borough of the CSA requirements to recover professional fees associated with the project. They have not responded to the CSA directly. The Commissioners authorized Mr. Napolitano to respond and inquire if they have any specific comments.

Mr. Pat Carberry Neglia Engineer:

Mr. Carberry discussed Item #4 Increase flow at Jony Drive pump station: Reference to discover the source of the extraneous flow Neglia will supply the Surveyors and field inspectors for GPS positioning to locate any unidentified manholes. All findings will be documented with photographs which will be included in a project summary, we will consider starting once the weather breaks prior to the spring weed growth. Mr. Curreri will coordinate a time frame.

- Although CSA has a Shared Service Agreement with the Borough, it was necessary to have an outside contractor clear up the heavy snow and ice at the pump stations. Following a discussion, the Board authorized Mr. Napolitano to respond with the agreement that the Pump Stations must take priority during heavy snow storms especially at Barell Ave. The Pump Stations cannot be plowed in, we require access in case of an emergency.

- Mr. Curreri reported that all Resolutions have been reviewed with the assistance of Mr. Napolitano and Robyn.
- February 17, 2021 we had our JIF inspection at both pump stations and note: The facilities are exceptionally well maintained on the interior and exterior. The Authority utilizes the Department of Public Works for snow removal at the pump stations. At Jony Drive pump station, the Authority replaced all electrical components following a lighting strike in the summer of 2020. There are no new suggestions for improvement.
