RATE HEARING

Executive Director S. Lahullier asked Vice Chairman C. Lahullier to have Certified Court Stenographer Candice Carucci swear in the Executive Director. S. Lahullier then proceeded to review/certify the 2024 Connection Fee/User Rate.

S. Lahullier submitted a copy of the following as exhibits for recording purposes to Ms. Carucci:

1. Resolution #23-47 Connection Fee/User Rate Tier I and Tier II Calculation 2024 2. Rate Calculations 2024

Executive Director Mr. S. Lahullier stated that the first order of business is the Public Hearing. This is required to be held by the State of New Jersey with respect to service charges that are to be charged by the Carlstadt Sewerage Authority for fiscal year 2024. The Statue requires that the Sewerage Authority recompute the Connection Fee which may be imposed upon those businesses or persons who subsequently connect in that fiscal year. The proposed connection fee for calendar year 2024, is the amount of \$4,197.41 per EDU. The user Rate for TIER I customers shall remain at \$9.25 per thousand gallons estimated based on annualized Veolia 6-month usage report of 160,562,432 gallons. The User Rate for Tier II users shall be the direct cost presented to the CSA by the BCUA for usage by that particular TIER II user plus a service charge of \$3.62/Thousand Gallons based on BCUA usage of 31,952,883 gallons.

At 6:05 P.M., Executive Director Mr. S. Lahullier indicated, for the record, that he is requesting a motion to open this Rate Hearing to the public. Mr. S. Judge moved the motion; seconded by Mr. C. Lahullier.
