# CARLSTADT SEWERAGE AUTHORITY CARLSTADT, NEW JERSEY REGULAR MEETING MINUTES OF NOVEMBER 13, 2019

## **PROFESSIONAL REPORTS**

**Mr. Cedzidlo Esq:** Reviewed the Public Rate Hearing Notice which Ms. Esposito emailed to North Jersey Media Group to be published in the Record and the Herald News.

Mr. Cedzidlo read his letter to Soul Tress regarding the sewer connection to the new lateral installed by 320 Paterson Plank Road. Soul Tress is not complying; Mr. Villano recommended that Mr. Curreri draft a letter stating the same once the date of disconnect is known. Mr. Curreri contacted the parties involved to get an approximate date when the lateral will be concrete filled and notify Soul Tress that they will no longer have sanitary sewer service, the water will be shut and Board of Health notified.

**Mr. Pat Carberry - Neglia Engineer:** Mr. Carberry discussed 655 Washington Ave. The engineer Mr. Fantina is requesting information and will serve a letter for the construction of a new warehouse. Mr. Carberry directed Mr. Fantina to our R&R website numerous times. A will serve letter will not be issued until certain criteria has been met by the property owners. They are to fill out the required connection application and establish an escrow account for review. Mr. Villano commented that the property will not be issued a will serve until all the criteria is met however, the Authority does have the capacity to accept additional flow at Barell Ave.

On Tuesday November 12, 2019 Neglia's surveyor along with Mr. Curreri located MH J-36 in the right of way off Veterans Blvd. The manhole has been marked off with bunting and a flag pole.

## **PAYMENT OF BILLS**

Mr. Curreri presented the Board with the November 13, 2019 Bills List Resolution #19-35. Mr. Lahullier made a motion to approve resolution #19-35; seconded by Chairman Maloney.

## OLD BUSINESS

Mr. Curreri reported that collections to date are continuing as expected.

Barell Ave sump pump check valve has been replaced by Rapid on October 30, 2019.

We have reviewed and accepted the previous agreement of the 2019 connection fee schedule presented by our Auditor. The connection fee calculations will be accepted at our December rate hearing.

The manhole at 100 Commerce was reset and repaved this Saturday. Mr. Curreri supervised the repair Chairman Maloney was also present.

#### **NEW BUSINESS**

456 Washington Ave: Mr. Curreri has been on site since October 24<sup>th</sup> on numerous occasions with All American clearing our Mainline. We found the first buried manhole. Neglia came in with the GPS to locate MH J36 which was marked with bunting. The owner is in the process of hiring All American to perform the necessary repairs to their lateral. Mr. Curreri found five (5) cleanouts on this property broken and three (3) on adjacent 484 Washington, which I will be sending a repair letter.

Amazon will be moving into 801 Washington Ave the old Nash Building.

Mr. Curreri worked on the connection fee. He also reviewed past audits that were available and forwarded all information to Paul. A bonded report will be available for December.

On Tuesday 10/29, Mr. Curreri inspected 320 Paterson Plank Road; performed a flow test. All manholes are clear. Borough Hall building notified. Pictures are on file.

On Wednesday 10/30, 456 Washington Ave Plumber hired by owner could not locate lateral. Upon further inspections with the assistance of the plumbing company we found four (4) cleanouts and also found lateral broken. The Owner is contracting a new plumber to locate lateral. He has been instructed to file a permit through the borough.

Bookkeeper completed monthly auditing for October and reviewed connection fee calculations.

Four (4) new padlocks were ordered for Pump Station gates and mechanical boxes. The broken lock at Barell could not be repaired; Locksmith could not rekey any locks. Mr. Curreri ordered 4 new locks with keys. Mr. Curreri has a combination bicycle lock on the gate at Barell Avenue. Mr. Curreri will change the 4 locks when everyone has new keys.

Located buried Manhole J36 at Veterans Blvd. Jug handle with Neglia via GPS locater. The manhole is roughly 35 feet in the meadows off the guardrail and marked with bunting.

The Rate Hearing is scheduled for December 18, 2019 at 6:00 P.M. Following the Rate hearing and regular meeting the board approved a holiday gathering.

Mr. Cedzidlo recommended that the board authorize Mr. Curreri to sign the proposed settlement agreement negotiated by Labor Counsel, Mr. Lahullier made a motion to authorize Mr. Curreri to sign agreement as recommended by counsel: seconded by Mr. DeSimone.
